APPLICATION

Current EWEB policy and Oregon State law (ORS 30.182) prohibits anyone other than EWEB authorized personnel from operating any portion of the water system infrastructure including EWEB-owned shut-off valves. The Customer Private Hand Valve Rebate Program was created to give financial incentives to encourage customers to install shut-off valves on the customer side of the water meter see picture on the other side of this form.

Rebate application must be submitted within 90 days of the customer hand valve installation. The person signing this form must be the responsible party for the water bill.

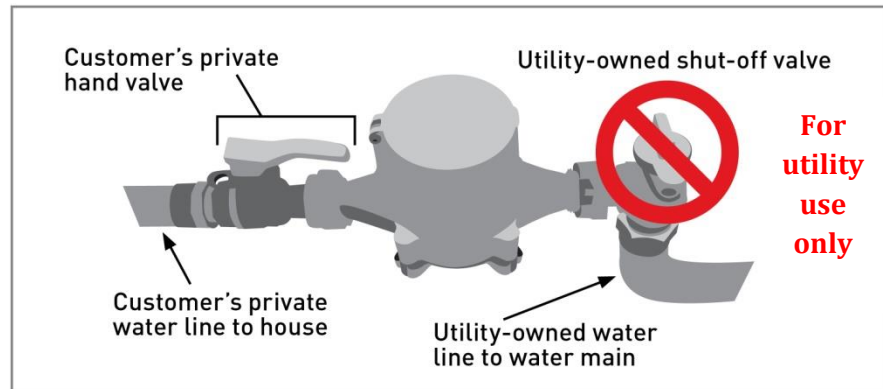

Rebate Eligible Private Hand Valves



All customer side private hand valves installed at the meter and at the potable connection between the existing indoor piping and the water service line must be one of the three non-lead hand valves manufactured by the following manufacturers:



Ford



Mueller



McDonald

Each private hand valve must be ¾ - 1 inch full port valves. Each private hand valve must have a handle attached to allow the hand valve to be exercised by the customer without the need of tools.
