## Narrative:

The Board is being asked to approve a new price agreement with **ERMCO Distribution Transformers** of Dyersburg, TN for the purchase of Polemounted Transformers on an as needed basis.

In October 2016, EWEB issued a formal invitation to bid to establish a price agreement for the purchase of Polemounted Transformers. The solicitation was reviewed by 13 companies. Five (5) responses were received; ERMCO Distribution Transformers was determined to be the lowest responsive and responsible bidder.

Responses were received by General Pacific of Portland, Oregon, Anixter of Portland, Oregon (who submitted two bids), WESCO Distribution of Portland, Oregon, and ERMCO Distribution Transformers of Dyersburg, Tennessee.

Historical procurement data suggests that the total contract amount will be approximately \$1,700,000 over the total five-year period. The actual total dollar amount, however, is unknown and may be more or less than that estimated volume. Purchases will be based on need and not on any specific annual quantity. The annual cost will be within the amount budgeted for that specific year.

If approved, staff will purchase required Polemounted Transformers at the established prices over the life of the contract. The contract is for five years.

## **ACTION REQUESTED:**

Management requests the Board approve a new price agreement with **ERMCO Distribution Transformers** for **the purchase of Polemounted Transformers**. Funds for this purchase were budgeted for 2016 and will be budgeted annually.
