| SUBJECT: | Review and revisions to Board Policy EL3 – Public Requests for Board Expenditures |
| OBJECTIVE: | Board review and feedback of governance policy EL3 |

Issue

As part of the Board's regular review of its governance policies, staff reviewed Executive Limitations 3, which relates to public requests for donations, sponsorships, grants and other direct requests for expenditures of public funds for community support.

Background

A governance policy was first adopted in 1987 to guide the Board in approving requests for donations, sponsorships, in-kind services and other community requests for utility funds. The policy was revised in 2005. The revised policy was intended to allow the Board to approve requests for such funds above \$2,000. However, the Board also approves annual budgets authorizing staff to expend funds for such things as energy and water education grants, Greenpower grants, watershed protection and research grants, general donations and sponsorships. Many are in excess of \$2,000. These funds are expended by EWEB management staff in accordance with the approved budget. However, the manner in which the policy is written may be interpreted as requiring separate and specific Board approval to expend funds in excess of \$2,000. For example, the annual \$50,000 Greenpower grants are included in the annual budget, are voted on by Greenpower customers and then awarded each year, without separate Board approval for each grant.

Discussion

Staff has proposed a revised EL3 governance policy to allow staff to efficiently consider, review and expend funds authorized by the Board through the normal budgetary approval process, but also to provide continued opportunities and authority for the Board to consider and approve community requests made directly to the Board or individual Commissioners. The draft policy provides suggested guidelines and limitations in accordance with EWEB's Community Investment Strategy, which can be found at: <u>http://www.eweb.org/investment</u>.

Requested Board Action

Management is requesting feedback from the Board on the draft revisions to EL3 at its March 1 regular meeting. The draft EL3 will be revised, based on Board direction, and re-submitted for final approval at a subsequent Board meeting.
