Operational Requirement and Alignment with Strategic Plan

The Hayden Bridge Filtration Plant currently disinfects the drinking water using gas chlorine. In 2014, staff, working with Jacobs (formerly CH2M Hill), completed a Disinfection Evaluation to replace the current gas chlorine disinfection system with a system that uses solar salt to produce chlorine disinfectant onsite. Previously staff have requested Board Approve purchase of onsite hypochlorite generators, storage tanks, metering system, and building construction services. The building and equipment operation is nearing completion and operation is expected by the end of the year which will require solar salt.

Contracted Goods or Services

Purchase of solar salt for use in sodium hypochlorite generation to be used at the Hayden Bridge treatment plant.

Prior Contract Activities

EWEB has not has a prior contract with Cascade Columbia Distribution. One time spot purchases are occasionally sourced from Cascade Columbia Distribution with positive results.

Purchasing Process

In May 2018, EWEB issued a formal Invitation to Bid (ITB 10-084-G) for the purchase of solar salt for Sodium Hypochlorite Generation. The solicitation was publicly advertised and three bids were received. Cascade Columbia Distribution was determined to be the lowest responsive and responsible bidder for solar salt, having met all bid and technical requirements.
