SUBJECT: Water O&M and Capital Budget Amendments

OBJECTIVE: Approval of Resolution No. 2024

Issue

Per Board Policy EL-1, the approved budgets are the maximum level of expenditure authorized by the Board. Management is projecting costs will exceed budget for the Water Utility this year due to an opportunity to invest in Water Source Protection related to the Holiday Farm Fire, as well as a shift in overhead from capital to O&M due to lower capital spending. Management is requesting Board approval of budget amendment.

Discussion

The Water Utility 2020 actual costs are expected to exceed the O & M budgets and the variances have been outlined in the table below. The Water Utility has had a strong revenue year, with income in excess of budget by \$1.4 million to date. After considering the unfavorable shift of overhead and labor to O & M, the Water Utility still has \$800,000 in unanticipated revenue to absorb increases in Water Source Protection. Water cash reserves are healthy and could be used to cover the balance of an addition of budget to source protection. More detail on the drivers of Water variances follows the table.

Water Operations & Maintenance

Operational Changes

The increase in Water Operation and Maintenance budget is based primarily on two factors.

- Water Source Protection investment
- Lower projected capital and accounting guidance and software capitalization both shifted costs from capital to O&M

Capital Budget

The Water Utility is anticipating a \$2,500,000 lower than budget capital spending. The primary drivers for the decrease are deferred work due to the COVID 19 pandemic.

Requested Board Action

Management recommends and requests that the Board approve Resolution No. 2024 to increase the Water O&M budget by \$1.9 million and reduce Water Capital budget by \$900,000.

RESOLUTION NO. 2024 OCTOBER 2020
