**ELIGIBILITY:** To receive the credit, Customer must first meet the minimum requirements and be approved for participation based on specific attributes of the Project.

**MINIMUM REQUIREMENTS:** Increased load (kW demand on meter) of 100 kW; additional annual EWEB revenue of \$25,000, and project has demand response capabilities.

**TERM:** Upon approval, Customer will enter into an agreement with a term of 2 – 4 years, depending on the economic benefits of the Project.

**APPLICABILITY:** The credit is an addendum to the applicable electric price schedule for qualified customers locating or expanding in EWEB's service territory. The credit is calculated annually based on annual projected wholesale electric market pricing and EWEB retail price schedule.

**TAX LIABILITY:** Customer is responsible for any tax liability which may be imposed as a result of payment of any incentives or as a result of obtaining financing. I understand that incentives or credits may be taxable and reported to the IRS.

**DISCLAIMER/NO LIABILITY:** The participant assumes the risk of any loss or damage in connection with installation. EWEB does not guarantee any particular energy or financial benefit estimates by its approval of the application.
